This review analyzed preeminent scholar of California History, Kevin Starr's examination of the recent past (the 1990s in particular) on how individuals imagine, create, and react to the conditions around them to determine California's history.

### **Book Manuscript In Progress**

Koslow, J. L. (2020). *Working Title: "Urban Renewal in Florida: The Contested Nature of a Cold War Policy"*.

In the mid-twentieth century, Florida used its powers of eminent domain to clear residents out of areas it deemed to be slums in favor of redevelopment. In this way, the story of urban renewal in Florida resembles the history that scholars have told elsewhere. However, appearances can be deceiving. In 1952, Florida became one of two states in the nation to reject federal funds for urban renewal. Consequently, studying the specific dynamics of "slum clearance" in Florida reveals a decidedly more nuanced story of the process, practice, and politics of urban renewal in a Southern context. I will be looking at Miami, Daytona Beach, and Tallahassee to illuminate this complex story. I began working on this project while researching the history of Smokey Hollow in Tallahassee. I had intended to begin research in earnest in the Summer of 2020. However, due to Covid-19 my ability to conduct extensive archival research in Florida and the National Archives has been put on hold.

I prepared a 23,000 word historical context for HALS FL-9: "The Smokey Hollow Community." HALS stands for Historic American Landscapes Survey, which is a National Park Service Heritage Documentation Program. The results are housed at the Library of Congress. From the 1890s to the 1960s, Smokey Hollow was home to working-class and middle-class African Americans in Tallahassee. Florida's state government removed houses, stores, and churches to make-way for post-World War II urban renewal projects. As part of a twenty-first century project to redevelop the area, the city of Tallahassee decided to create various commemorations to this former community through the construction of spirit houses, interpretive signs, and a HALS. The historic context document provided a crucial foundation for this commemoration. I believe a HALS is equivalent to a short book in terms of the process and product (primary research, secondary context, peer review.) In terms of process, I was responsible for the historical research and for writing the historical report for the HALS. As an expert on African American history, Anthony Dixon, Ph.D. reviewed the draft prior to submission to NPS. An employee from the National Park Service was responsible for the specialized photography and drawings. In terms of peer review, the nomination was reviewed by the National Park Service, which employs professional historians and architects to review submitted materials. I prepared a nomination to add Meridian Road to the National Register of Historic Places, which is a National Park Service program. The nomination was accepted in 2013. Meridian Road is associated with the growth and development of Leon County, Florida, which for a time in the nineteenth century and into the early twentieth, was the center of cotton production in the state. The road served as one of the major local conduits to move agricultural products from the county's plantations and farms to market in the capital city of Tallahassee and to shipping points on the Gulf of Mexico. This major thoroughfare continues to connect the rural areas of Leon County to the City of Tallahassee. I believe a National Register Nomination is equivalent to an article in terms of the process and product (primary research, secondary context, peer review.) In terms of process, I was responsible for the historical research, writing the narrative detailing the historical significance, and for the parts of the narrative explaining the historic appearance of the road. The State Historic Preservation Officer aided in the technical logistics of the application: photographs, current physical description, and non-historical elements. In terms of peer review, the nomination was reviewed by the State Historic Preservation Officer, Florida National Register Review Board (which is composed of archaeologists, historians, and preservation architects), and the Keeper of the National Register of Historic Places, who is an employee of the National Park Service. As part of a community engagement project, I conducted historical research and synthesized secondary sources into a narrative regarding the Tallahassee bus boycott and sit-ins in Tallahassee. Tallahassee was the site of the second major bus boycott in the United States, demonstrating to the world that the events in Montgomery were not an aberration. In the spring of 1960, students engaged in sit-ins. In an unprecedented move, those in Tallahassee chose jail over bail. I worked to find primary sources that could be used by FSU's Master Craftsman Studio to incorporate into their designs for a commemorative sidewalk (The Studio used terrazzo to render the images.) I also prepared the narrative describing these events and their meaning, which the Master Craftsman Studio has rendered in bronze as a portion of the sidewalk. The sidewalk starts on the corner of Monroe and Jefferson and extends down Jefferson street. In terms of process, I did some primary research for photographs but the text was based on a synthesis of secondary materials, similar to the process of an encyclopedia entry. In terms of peer review, the materials were reviewed by the citizens committee brought together by the Community Redevelopment Agency (TCRA) (a city/county agency), as a consequence there were scholars and citizens who participated in the review process. I began work on this project in the Spring of 2010 and it took a year to complete. The sidewalk was laid in Fall 2013.

The Florida Supreme Court Historical Society funded one graduate student for one year. The project dates were September 2009 to September 2010 and the total award of funding was \$20,729. The project resulted in a history of African American experience in relation to the Florida Supreme Court since *Brown v. Board of Education* (1954). The report also served as the material basis for the production of the text and graphics for a small traveling exhibit.
